- *Mosaic: The Magazine of the Jewish Federation of Greater Los Angeles* (December 2007)
Three JFLA business loan recipients are profiled in the article “Who Said There’s No Such Thing as a Free Lunch: JFLA’s Interest-Free Loans.”
- *Los Angeles Business Journal* (November 12-18, 2007). On page 3’s “Up Front” section, reporter Sarah Filus profiles JFLA’s small business loan program, and gives a brief overview of JFLA history and community impact.
- *Jewish Journal of Greater Los Angeles* (September 16, 2004). Reporter Marc Ballon writes a feature story about the JFLA traveling exhibit. The story, titled “Exhibit Celebrates Century of Dignity,” discusses the 100 year history of interest-free lending and lists the synagogues that will host the exhibit during this anniversary year.
- *Los Angeles Times* (August 30, 2004). On the front page of the California Section, reporter Bob Pool profiles the agency’s 100 years of interest-free lending in a feature story titled “Lenders Rely on Faith in Humanity: The Jewish Free Loan Association hasn’t charged interest for 100 years but gets its money back.”
- *Jewish Journal of Greater Los Angeles* (September 19, 2003). In reporter Michael Aushenker’s weekly column of events, “The Circuit,” ran a brief story and photo entitled “The Loan Rangers.” The focus is the unveiling of JFLA’s Zerner Family Wall of Recognition, as part of our Endowment Fund Campaign for our 100th Anniversary next year. The photo is of the Zerner Family and Evelyn Schecter standing near the Wall of Recognition.
- *Jewish Journal of Greater Los Angeles* (July 4, 2003). In a Letter to the Editor, Culver City resident Sydni Bender writes in response to the below article about JFLA’s in vitro loan program. She applauds JFLA on serving members of the Jewish community.
- *Jewish Journal of Greater Los Angeles* (June 12, 2003). Journalist Marc Ballon writes a feature story entitled “Loans Give Hope to Infertile Couples.” The article discusses JFLA’s Lerner Family Adoption Loan Fund, specifically those loans granted to couples undergoing fertility treatments. Two loan recipients were interviewed, as was Evelyn Schecter, and the article includes a photo of triplets born with help received from JFLA.
- *The Chronicle of Philanthropy* (May 1, 2003). This weekly newspaper, serving the national nonprofit sector, ran an announcement of JFLA’s new Director of Major Gifts, Elliot Friedland, in the “People” section.
- *The Messenger* (January 31, 2003). This bi-monthly newspaper, serving the traditional communities of Los Angeles, ran a word-for-word news release regarding the opening of JFLA’s new Thousand Oaks office. The release also featured information about JFLA’s West Hills office.

- *The Forward* (December 16, 2002). A brief in the “News Desk” section discusses loans for Iranian émigrés. Evelyn Schechter is quoted regarding JFLA’s loan program for Iranian émigrés, funded by the JDC and the Iranian Jewish Federation. She explains that since the fund began in May 2001, 86 loans have been granted, totaling \$186,000.
- *Jewish Journal of Greater Los Angeles* (November 1, 2002). Reporter Marc Ballon writes an article entitled “Middle-Class Poor: A Growing Number of Poor Jews is Taxing the Capabilities of Charitable Services.” In it, Executive Director Mark Meltzer discusses the state of JFLA as we enter 2003, and a JFLA client shares his story about receiving a loan.
- *Jewish Journal of Greater Los Angeles* (June 21, 2002). In reporter Michael Aushenker’s weekly column of events, “The Circuit,” he summarizes JFLA’s Afternoon Tea & Silent Auction held on June 6th and featuring handbag designer Dianne Schweitzer. He also summarizes JFLA’s mission and provides our phone number for additional information.
- *Jewish Journal of Greater Los Angeles* (March 8, 2002). Reporter Michael Aushenker writes a piece entitled “JFS Picks Up Several JCC Services.” At the end of the article, he explains that in addition to Jewish Family Service, JFLA and JVS would also be offering services to laid off employees of the JCC’s and the Federation.
- *Los Angeles Times Magazine* (February 25, 2002). Executive Director Mark Meltzer submitted a Letter to the Editor in response to an article titled “Giving Up on America,” that ran on January 27, 2001. The article featured a young Latvian attorney who came to America to escape on-going anti-Semitism, but moved back to Latvia a few months later, apparently not wanting to undergo the hardships that many immigrants face in their first few years in a new country. Mark’s letter pointed out that there were several resources within the LA Jewish community of which this young man failed to take advantage.
- *Los Angeles Daily News* (December 10, 2001). Barbara De Witt announces the Short-term Home Healthcare Loan Fund in the blurb “Healing Help,” appearing in the L.A. Life Health Section on the “Pulse” page, L5.
- *Los Angeles Business Journal* (November 26-December 3, 2001). Announcement of David Silberg elected as the new president of JFLA on the “Newsmakers” page 21.
- *Jewish Journal of Greater Los Angeles* (November 23-29, 2001). “Those Who Will Suffer,” a story by reporter Mike Levy tells the story of one Jewish man who has benefited from many of the services that the agencies of the Jewish Federation offer. Executive Director Mark Meltzer is quoted about the downturn in the economy and its affects on JFLA. Page 8.
- *Jewish Journal of Greater Los Angeles* (November 23-29, 2001). Editor Rob Eshman titles his weekly column for this week “Needful Things,” and includes JFLA as one of the agencies on the front line of helping those in need in the community. Page 3.
